## Description

Gaska Tape's V1500 Series product is a medium density closed-cell Polyvinyl Chloride foam. The tape provides an excellent combination of flexibility and conformability with strength and wear resistance. Performs in those "tough duty" applications where a tape must still flex to fit and seal.

Characteristics common to all closed-cell vinyl foam products include the ability to make a long life seal against air, moisture, light and dust penetration. Closed-cell vinyl foam completely seals out air, moisture, light and dust when compressed 30% or more.

  - Available with A3 adhesive, an aggressive acrylic that provides an excellent combination of tack and holding power. Bonds quickly to most surfaces that are kept clean, dry and free from contamination.
